Through a series of case studies of movements conducted by women, women of color, and workers in the United States and in the OECD countries, Weldon examines processes of representation at the local, state, and national levels. Indeed, Weldon argues, the effectiveness of social movements suggests that we ought to promote them through public policy. Yet using government policy to catalyze what must be independent movements is a tricky business, fraught with tensions. Weldon proposes that one way to spark such movements is the creation of an advocacy state: a state aimed at furthering the mobilization of marginalized groups both within the governing bodies and in civil society. She concludes with specific policy recommendations for improving

Challenging the Mandate of Heaven

In the study of civil society and social movements, most cases are based in Western Europe and North America. These two areas of the world have similar histories and political ideals and structures in common which in turn, affect the structure of its civil society. In studying civil society in Asia, a different understanding of history, politics, and society is needed. The region's long traditions of centralized, authoritarian states buttressed by Confucian and in some cases Communist ideologies may render this concept irrelevant. The chapters in this international volume cover most of the areas and countries traditionally defined as belonging to East Asia: Japan, Taiwan, South Korea, Hong Kong, Singapore and China. Memes to Movements

Political protest and social movements are ubiquitous phenomena. This book focuses on the current theoretical approaches that aim at explaining them: the theory of collective action, the resource mobilization perspective, political opportunity structure theory, the identity approach, the framing perspective, and the dynamics of contention approach. The book has three objectives: (1) Many basic concepts like political opportunities or identity are not clearly defined. It is further often a matter of interpretation what factors are supposed to affect which phenomena. The first aim is therefore to provide a detailed introduction to and a clear restatement of the theories. Only then is it possible to assess and improve them.
